### **About FAVA**

The idea of forming a regional organization whose membership will be composed of the different professional veterinary associations of Asia was initiated by the officers of the Philippine Veterinary Medical Association (PVMA) in December,1974 led by its President, Dr. Teodulo M. Topacio, Jr On February 18, 1976, the officers of the PVMA led by Dr. Topacio, met with Dr. Katsuji Sugimura, of the Japan Veterinary Medical Association (JVMA) and agreed that the veterinary associations of Asia should be organized into one Federation. Subsequently, FAVA was formed on  $22^{nd}$  February 1978 with veterinary associations from Philippines, Malaysia, China Indonesia, Japan and Korea as founding members. Since its founding, FAVA has held the FAVA Congress every two years, hosted by the respective



country Veterinary Association, The Executive Council of FAVA meets every year and likewise is hosted by the respective country Veterinary Association. The 1st FAVA Congress and the 1st Executive Council of Representatives was held in Manila on February 21-23, 1978, at the Philippine International Convention Centre. As a regional organization, FAVA can be considered as having accomplished its objective of fostering closer relationships and understanding among the veterinarians of Asia which were non-existent before 1978. This therefore can be considered as its most significant achievement through cooperation amongst FAVA members, organizations and authorities promoting One Health, animal welfare, veterinary education, strengthening of regional networks, and connecting to global veterinary networks to further develop and augment the veterinary profession especially in Asia-Oceania region.

### Vision

To be recognised both by the public and governments as the pre-eminent professional veterinary association serving the needs and welfare of the human and animal as well as environment in Asia-Oceania region.

#### **Internal & Collaboration**

- 1. Advocate and assist the establishment and development of veterinary profession in Asia-Oceania region.
- 2. Continue and establish strong networks among member countries and relationships with international organizations, government and industries to improve human-animal-environment health and animal welfare.
- 3. Increasing membership, partners and sponsors and their participation in FAVA.
- 4. Initiate review and update of the Constitution and By Laws.
- 5. Improving the secretariat & office operations, communications and publications.
- 6. Supporting a limited traveling expense for member countries from developing countries to attend<del>ing</del> FAVA council meeting and/or congress.

#### **One Health**



- 1. Provide education and training to member countries on One Health topics.
- 2. Providing resources for media and advocacy to associations; by highlighting the One Health role, in particular the importance of the threat of emerging and re-emerging diseases; and by establishing strong internal communication at the FAVA council level.

- 2. Provide assistance to all FAVA member countries to improve educational standard of veterinary education.
